1. Review of minutes from $3 / 12 / 24$ (taken by Kelly Y.). Motion to approve as written by Kendra, Tom seconds, motion carries unanimously.
2. Financials:

- Request to summarize donations in reconciliation report, instead of every donation name showing up. Or list donations as "anonymous" instead of naming donor.
- Overall for year, we are only $\$ 388$ short (income vs costs).
- Question about high gas bill. ACTION: Deb will investigate bill.
- Kendra asked about getting a Nest installed to control heat and A/C. ACTION: Luther will check into a programable thermostat.

3. Old Business
-Election for open board seats is Tuesday, June $18^{\text {th }}$

- Voting will again take place online and in-person.
- 2 months before (April $16^{\text {th }}$ ) members should send Luther an email to express interest in running for a board seat.
- 1 month before nominations close.
- 2 weeks before, online voting starts.
- If new by-laws pass, new recommended amount of board members will be 7 . Since they haven't passed yet, suggestion to set board at 8 members because it complies with current and proposed by-laws.
- Deb moves to set amount of board seats at 8 for 2024-2025, Tom seconds, all in favor. Motion carries. Guest Chris B. expressed concern over having an even number of board members.
- Discussion on dinner and possible presentation during election/membership meeting. Proposed "State of the Club" to update membership on what's been happening at the Club since transitioning away from Club Manager and Administrator. All board members can speak, ACTION: Kathleen will send a list of proposed topics to discuss during State of the Club.

4. New Business
-Spring Clean Up

- Catherine and Kendra will head up effort, to take place at 10:30am Saturday April $27^{\text {th }}$. Potluck style breakfast provided by volunteers.
- Catherine asked question about turning water on since some plan to power wash outside of building. ACTION: Deb will contact Cottage Gardner (previous gardener) to ask.
-Trash
- Kendra brough up continued issues with trash removal. She brough over bags of trash to Villager dumpster during last potluck and theatre owner complained again. ACTION: Kendra will contact GLF and ask about options (possibility of driver picking up trash container at building instead of curb).
-Display case outside front door
- ACTION: Kathleen will start an email to get ideas from board on what to hang in display. Kendra will print, laminate, and hang information.
- Budget corrections were made. Contract for Mike C. goes through June 30, 2024 so $\$ 400$ was added to budget. Zoom annual cost of $\$ 170$ was added.
- Deb tried to cancel the cable today but could not do it online. ACTION: Deb will call Charter and cancel cable.

Can be addressed in 3-6 months per Luther, he doesn't anticipate rent club is getting will be much different. A small amount will move up line to AA services, District 13, etc. Discussion tabled to see how first few months work out.

- Kevin wondered if rent increases in summer. Yes, but Club is still usually 10 K /year short (costs vs income)
- Betty reminded that Club can fundraise, but AA groups cannot.
